Dear Parents/Guardians,

As part of the extra-curricular activities offered by Holland Park State High School, students have the opportunity to participate in a variety of school sporting events. These events include interschool and recreation sport, Metro Finals and our school wide carnivals such as swimming, cross country and athletics.

Sport (both inter-school and recreation) occurs on a Tuesday for Years 7, 8 and 9 and Wednesday for Years 10, 11 and 12. On the corresponding day, students are expected to wear their full school sports uniform. This allows for students to be prepared for the afternoon physical activities. At Holland Park SHS we encourage all students to participate in interschool sport to the best of their ability.

Students will be expected to pay an upfront payment (cost to be confirmed) for interschool sports in 2024. This upfront payment is used by the school to pay for transportation and facility hire fees.

Attached to this letter is a table of the interschool and recreation sport options and their cost. Students will be expected to pay the resource hire room the total amount by round three of that particular season (Summer 8th March / Winter 7th June). Failure to meet this deadline may result in the student being changed into a school-based activity.

Once students have selected a sport they will engage in a trial before teams and sporting options are finalised. For your child to be considered for their chosen sport they must return the attached permission slip to their care teacher no later than Friday 9th of February 2024. This form must be completed before the student can participate in any sport outside of the school grounds.

Additionally, you will find attached two Activity Consent Forms for the 2024 swimming carnival and highrisk athletic events – discus and javelin. These consent forms provide permission for your student to attend and participate in the 2024 swimming carnival and the high-risk events in curriculum classes and, should they choose, the 2024 athletics carnival. These consent forms must be returned to their care teacher no later than Wednesday 6th December 2023.

Please note:

- Sun Smart policies dictate that it is imperative that students wear a hat that conforms to the sun smart policy and the school uniform.
- The Department of Education does not have Personal Accident Insurance Cover for the students.

- Ensure there is a suitable distance (e.g. 5m) between throwers at all times.
